Chapter Five Outline

John is now in Heaven with the Raptured Church and he is describing what is taking place.

Revelation 5:1

- Two sided scrolls in ancient times were clearly recognized as legal documents
- Father GOD, Jehovah has brought out His Title deed for His entire creation.

Revelation 5:2

- Only a human being can open the scroll, a descendant of Adam & Eve. That is the heritage requirement.
- The financial requirements are any and all debts, we call them liens placed upon this title deed must be paid in full to the owner.

Revelation 5:3-5

- What is our debt or lien placed upon GOD'S title Deed?
- For all have sinned and fall short of the glory of God. Romans 3:23
- No human being alive or dead in Heaven or Hell can meet the requirements for opening the scroll, and bring to an end Satan's reign of sin.
- Sin is our debt to GOD on His Deed & this is the price of our debt:
- For the wages of sin is death, but the gift of God is eternal life in Christ Jesus our Lord Romans 6:23
- Our debt upon GOD's scroll is death.
An Elder points out to John that Jesus has overcome; He paid our debt.
- The details about the scroll and Jesus are now strictly Jewish.
- As in the Church Age is complete & once again GOD is dealing with Israel.
- Jesus the Lion of the Tribe of Judah.
You are a lion's cub, Judah; you return from the prey, my son.
- The scepter will not depart from Judah.
- Jesus is a descendant of Judah and He shall rule.
- The Root of David
- Deity becomes the human lineage of David, John Chapter 1 explains this well.
- GOD is a triune Trinity of 3 distinct persons.
- Jesus is the hands and feet, the working living Word of GOD.
- Jesus was the part of GOD born human.
- All things were physically made by Jesus, through the Holy Spirit, by the plan and will of the Father.

Revelation 5:6

- The Lamb who had been slain is Jesus's appearance after paying our cost upon the cross.
- Jesus: our advocate, our intercessor, Savior, King and High Priest, our Government and Spiritual leader.
- Jewish tradition of the Passover lamb was so that even a child could understand the seriousness of sin before our Holy and Just GOD.

Revelation 5:7

- From the hand of Almighty GOD Jesus is handed the Title deed of the Earth and all of mankind that will accept & obey Him.
- Jesus has been proven worthy by His virtue, His actions, His motivation, & His qualifications.

Revelation 5:8-10

- The Elders once again prostrate themselves for something glorious and momentous has again happened.
- The Lord Jesus has just redeemed the Earth.
- Why Israel?
- In short Israel is created and chosen to be the world's clergy.
- Three times Moses gave warning that Israel would be disbursed.
- We mark time by decades, the Jewish people by their GOD given lunar Sabbatical calendar, their seasons and feast days are prescribed for them by GOD.
- Ancient Israel kept time in cycles of 7 years. This will come up again and be a major key for us to unlock and understand the Book of Revelation.
- The details GOD sent by an Angel to Daniel for him to record and preserve Israel's timeline from Daniel unto thy Kingdom come.
- Christ knew that He had to be revealed legally at this exact time to fulfill this prophecy.
- 7 year cycle remaining yet to be fulfilled.

Revelation 5:11-14

Jesus is our Goel or Kinsman Redeemer


He meets these 4 conditions of qualification
